# **JOHANNES MERTZ AND HIS DESCENDANTS**

This is one of eight "original ancestor" books that comprise the Mærtz Hierarchical Project. Mærtz is used to encompass persons named Mertz and Martz (and occasional other spelling variations).

Hierarchical Project describes a designation system wherein immigrants of this name are given one letter designations — Johannes is J and each male descendant of up to possibly six generations is given a 2, 3, 4, 5 or 6 character designation code which indicates the exact way in which that descendant relates back to the original ancestor.

For example: J2a4b1 would be the first son (1) of the second son (b) of the fourth son (4) of the first son (a) of the second son (2) of Johannes (J).

A project like this needs to have some limits and the general limits in this project are it covers males born before 1850 who then appeared by 1880 as head of household in their own right in Census.

The persons so designated are covered in this book sequentially — that is to say all persons whose designation is or starts with J1 follow J and come before J2. All persons whose designation is or starts with J2 come before J3. And so forth.

# Birth, Parent-Proof, Designation

The records of Moselem Church note the 1756 marriage of Johannes Mertz and Rosina Haffa and say that Johannes, a wheelwright, was the son of Johannes "*aus dem Wurtenburgishem Stochenhausen*" (from Stockhausen in Wurttemberg, Germany). That record was written by the minister who married this couple and I have seen other similar citations for immigrants which named the father back in Germany and I have no reason to think it wrong.

Now there are some people who state in their family trees that John Henry Mertz, founder of Mertz Church, was from Stockhausen. For example, my father's cousin who did his genealogy in about 1970 told me, mistakenly, that I was descended from John Henry and he also told me, mistakenly, that John Henry came from Stockhausen. (When I later went to Germany and asked German friends where Stockhausen was, they said it just means "a village" as opposed the name of a particular village.)

But the truth is the record says that about Johannes and only Johannes. So either people totally misunderstood that fact or they *assumed* that John Henry was a brother to Johannes. But that can be ruled out since we now know the name of John Henry's father (it was not Johannes) and the names of his brothers (there was no Johannes) and where John Henry was from (it was not Stockhausen).

It is a fact that Johannes, John Henry and Jost all worshipped at Mertz Church at some time and that seems to be where they all started out in the new world. Later, they and some of their descendants migrated from there. So, they may have been related, for example cousins of some sort. If we could ever find a known descendant of Johannes, then his DNA could prove whether or not John Henry and Johannes were related or not. Until then, I just don't know.

Johannes gets the single letter designation J. He is one of the five Mertz "original American ancestors" who settled in Berks County. The other three "original American ancestors" settled elsewhere.

Johannes and Rosina were named twice in the records of Oley Reformed too, as sponsors, in one case for a son of Christoph Gerhard in 1764 and the other for the son of Johannes Friederich and wife Eva in 1766. It is curious their associations at times with Mertz Church, at times Moselem and at other times with Oley and also interesting that their marriage was recorded at both Moselem and Mertz Church.

# **Relocated and Census Tracking**

The thing I don't know for certain is whether Johannes was the immigrant of that name who came in 1749 or was instead the immigrant listed as Hans Martz who came in 1751. I had always thought Johannes was the 1749 immigrant as that is what Morton Montgomery said but then I read a published family history that mentioned Johannes (the one associated with Mertz Church) as the other guy -- Hans in 1751. I consider neither source authoritative and will simply say I don't know which was Johannes (though I still lean to the 1749 guy) but it really doesn't matter. We're discussing here the Johannes associated with Mertz Church. I think he arrived 28 Sep 1749 on the ship Ann.

In the <u>Annals of Berks County</u>, Montgomery tells the story of Johannes Mertz. He was the son of Johannes of Stockhausen, Wurttemberg. He emigrated in 1749 and married Rosina Hase daughter of Melchior in 1756. Their children were Johannes 1757, Anna Maria 1760, Maria Salome 1763, Melchior 1765 and Peter 1769.

# Discrepant Facts

Several of the early sources many people have relied on when researching their Mertz ancestry clearly imply that Johannes is the "key immigrant" of the Mertz family in America.

J L Floyd called him "the founder of this family in America" while Joseph A Meiser amended that description and said Johannes' father, who did not emigrate was "the progenitor of several of the Martz (Mertz) families in America" (i.e. several of the other immigrants were thought to be brothers of Johannes) and both of those sources said "the church located near his home was named Mertz Church in his honor".

All those statements are wrong!

- Johannes was only one of the eight early immigrants I have identified. In terms of known descendants, he has about the fewest of these eight immigrants.
- I can absolutely declare that two of the other immigrants were not related to him in any way, two others were definitely not his brothers (though may have had a more distant relationship to him) and I think it unlikely the other three were related to him in any way. I think his father was the progenitor of just Johannes and his descendants, no one else.
- Mertz Church was named for a different immigrant, John Henry Mertz. Johannes came to America after the church was founded on land donated by John Henry. Johannes did baptize several children in that church but his family was not nearly so prominent in their early records as John Henry's.
- A Berks County deed clearly records the fact that John Henry Mertz donated the land for Mertz Church. The recording of baptisms at that church began in 1749 but the first page of the register lists all of John Henry's children baptized prior to 1749. He was the only church member for whom there was such a "catch-up" list. He was clearly considered the founder and that church was clearly named in honor of him.

# **Death and Find-a-Grave**

The estate of John Mertz, wheelwright of Maxatawny, entered administration 13 May 1773 with Rosina the widow as administrator. (Her sureties were from Maxatawny Township, Oley Township and Reading). I have examined his estate file, unfortunately there are no clues as to the names of his children.

# **Known Daughters**

We know his two daughters from their baptisms:

Anna Maria was born on 2 Dec 1760. Maria Salome was born on 24 May 1763.

[As an aside, in the records of Rev Stoever, there is record of the birth of Maria Barbara Mertz in 1751 daughter of Johannes of (or at) Northkill. It is not at all clear who this Johannes was -- another immigrant or this Johannes with a first wife prior to Rosina?]

# Known Sons

We know for sure two sons of Johannes from their baptisms:

J1 Johannes was born on 17 Jul 1757 and baptized at Moselem.

J2 Melchior was born 11 Apr 1765 and baptized at Mertz Church. His is a unique name in the Mertz families, he was named after his wife's father.

Many sources -- including Morton Montgomery and Charles A Fisher -- that were often accurate, though sometimes had errors -- add a third son:

J3 Peter, born, supposedly, 9 Mar 1769. There does seem to have been such a man, I know something about him and otherwise I do not know who he was but I have never seen the absolute proof that he was the son of Johannes. There was no record of Peter's baptism that I have found. However, I include him here as his third son.

Of the five Berks County Mertz immigrants, Johannes is the only one that I worry may have had a son I haven't yet identified. I think he had just those three sons but I'm not 100% certain. If I totally believed Morton Montgomery, I would conclude that these were his only three sons, I just have to leave open the possibility that maybe there was another one no one knows about.

# Birth, Parent-Proof, Designation

Here are some facts pertaining to one or more men named John Mertz who had some association with Maxatawny Township, Berks County.

A. Johannes Mertz son of Johannes and Rosina Mertz was born 17 Jul 1757 and baptized at Mertz Church 31 Jul 1757. I have no idea what happened to John, the infant. There is no way to exactly find another later record of a John Mertz and say, absolutely, that's him. Johannes, the father, died in 1773 and his estate file said he was of Maxatawny Township.

B. The only John Mertz or Martz listed in the 1790 Census — anywhere — was John Mertz who lived in Maxatawny Township, Berks County. The household consisted of one male over 16 and one female. In 1800, John Mertz was again listed in Maxatawny Township, now age 26-44 as was his presumed wife and they had 4 sons under the age of 10. In the 1800 Census there was only one other John Mertz anywhere and he lived in Longswamp Township. John of Longswamp was a known member of the Longswamp Mertz family.

C. There must have been a John Mertz living in or near Kutztown in 1791 whose wife was Margaret because a John Martz died in 1853 in Union County, PA in that brief period when death certificates were being filed and his said he had been born in Kutztown, PA in 1791 and his parents were John and Margaret Martz. Kutztown is in Maxatawny Township.

The obvious question is: are A, B and C the same man? I believe they are. I believe it most certainly must be that B and C were the same person, so the question really pertains to A.

Was A still alive in 1790? I don't know. There is no record of his death but there is nothing known about B or C that would prove they were A.

Was there any other candidate John who could have been B, the man reported in the 1790 Census? The answer is there is one slim possibility that has to at least be considered.

A pattern I have observed is that even as the Mertz families of Berks County slowly began to expand geographically in the late 1700's and thereafter, one thing is clear — as they spread to different townships in and beyond Berks County, they still tended to stay in clusters of closely related people. When you find multiple people named Mertz or Martz in one specific township in 1790 and even up to the 1840 or 1850 Census, it was either father and son(s) or brothers or perhaps first cousins. This family went to this township, this other family went to a different township but if you tell me the township, I can tell you the family. There are a very few exceptions but not many.

The sons and grandsons of Jost Mertz, for example, moved to Macungie Township, (now) Lehigh County and all the Mertzes of that place well into the early 1800's were that line. The sons and grandsons of Hans Peter Mertz moved to several different townships in Northumberland County before 1800 and up until 1830, all the Mertzes of Northumberland (including Union and Snyder) counties were of the Hans Peter line. So it is in Maxatawny Township. Except possibly for John (B) in 1790 and 1800, all the other Mertzes of Maxatawny to at least 1850 were sons or grandsons of John Philip Mertz (H1). Philip himself is the only other Mertz in Maxatawny in 1790 and 1800, and then was joined by his son Daniel in 1810. There were no Mertzes in that place in 1820 and 1830 and then several of Philip's grandsons showed up in 1840 and 1850.

So it has to be considered that Maxatawny was Philip's township and John of the 1790 Census was Philip's son. Philip had two sons whose baptisms were recorded at Mertz Church and two more who I have concluded were his sons even though no baptisms were recorded.

The main argument in favor of John being Philip's son is geography, Maxatawny. There is though a problem of timing. Philip married in 1764, had Catharina in 1765, Maria Elisabeth in 1766, William in 1767, Anna Maria in 1769, Jacob in 1770, Philip in 1772, Christina and Ester in about 1776, Daniel in 1779 and Hana in 1783. If he had a son John who was age 45+ in 1810 and who had his own son in 1791, he must have been born in that one gap year 1768. Even so he would only have been 42 in 1810 but that is a possible discrepancy that sometimes happened in Census.

The counter argument — to support the proposition that A=B=C — is that Johannes the immigrant was at least at times associated with Maxatawny Township too. Yes, he was named at times in the records of the Moselem Church, at times Oley and at times at Mertz Church. (The Moselem Church is quite near Kutztown.) When Johannes died, though, it was explicitly said he was of Maxatawny Township. His wife's sureties were from Maxatawny in one case, Oley in one case and Reading.

Johannes may have had interests in both Oley and Maxatawny. Johannes's son Melchior, who with such a unique name can be easily tracked, was reported in Oley Township in 1790 and then he died and his sons later showed up in Ruscombmanor then Maidencreek Townships. So it is not a slam dunk to say Johannes was of Maxatawny, but it is one place he was associated with and the one statement in the estate document is a key indicator.

But there is one additional point. Clearly, John born 1757 existed. I can't say for sure he survived but he was born so he existed. John, possible son of John Philip, is merely postulated. There may have been such a man but his existence is only suggested by the fact that a John Mertz lived near Philip in 1790 and 1800.

My best guess is that Johannes born 1757, son of Johannes the immigrant, did survive and was reported in Maxatawny Township in 1790 and 1800 and married a Margaret and had a son John in 1791 in Kutztown.

Johannes born 1757 is designated J1.

# Relocated and Census Tracking

So it is my contention that John Mertz of Maxatawny Township in the 1790, 1800 and 1810 Census was John (J1). But then what happened to him? Let's take a more comprehensive look at all the John Mertz or Martz, decade by decade.

There was only one John Mertz (all spellings) in all of America in 1790. Well, I'm not counting a man indexed as John Morits in Whitehall Township, Northampton County that someone has annotated to say he was John Martz. The name really does look like Morits and, in fact, there were four other men of that name in Northampton County. But that name appeared nowhere else and then even disappeared from Northampton in 1800. But I think it was not Mertz.

In 1790, John's household had just one male (himself) and 1 female, probably his recent bride.

In 1800, there was another John Mertz (P3a) in Census in Longswamp but I am totally clear on who he was. John and his wife in Maxatawny were 26-45 and they had four sons under 10 and one daughter.

In 1810, the number of John Mertz and Martz in Census explodes. There was this one in Maxatawny plus:

- In Shamokin Township, David's son John, P2a.
- In Salisberry Township, a John Mertz I'm not sure of but perhaps was George Heinrich's son H6b.
- In Allen Township, Heinrich's son John. H4c.
- In Macungie Township, a man indexed as John Martz but it is very hard to read and clearly sorted together with names beginning with W.
- In Bern Township, there was John Merts Sr. and John Merts Jr. in Bern Township. I have no idea who these two were but I've studied their names as written and I believe the name was Werts. You have to examine the way the Census taker wrote his M's in, for example, Michael, versus how he wrote his W's in, for example, William.
- Finally, in Upper Mahanoy Township, there was a John Marle. He was actually John Martz, P3a, who had moved from Longswamp to Mahanoy in the early 1800's.

But this John, whoever he was, was still in Maxatawny and then he and any remnant family of his seem to just disappear from Census.

In 1820, there were 11 men named John Mertz or Martz. For the most part I can identify them except there are two I can't identify who greatly pique my curiosity: John Sr. and John Jr. in Derry Township, Columbia County. When I was studying these Census listings, I formed a theory that John Sr. and Jr. of Derry were none other than this John and now his son John (the one born 1791) — but that's all it was then, a theory with no corroborating evidence.

That all changed in 2019 when I was studying land records of Columbia County. In 1813, John Mertz of Derry Township (recently removed from Northumberland County and made part of the newly formed Columbia County) bought land in Derry Township which he then, in 1819, sold — with wife Margaret. Margaret is the corroborating evidence. It was John (J1) and his son John (J1a) who were present in Derry Township in the 1820 Census.

# Death and Find-a-Grave

I don't know where John last lived, I do not know where he died.

# Known Sons

I have done a little bit of guessing here. I have guessed that John of Maxatawny Township in Census was the son of Johannes born in 1757 and moreover that he, with wife Margaret, had a son John in Kutztown in 1791. I believe that both John II and John III then moved to Derry Township by 1820. And then John III — meaning John born 1791 in Kutztown moved to Hartley Township, Union County. I pick up his story next.

I've been aware of this John for a long time, but never before had any idea where to place him. I call him my mystery John. This John is important to me because he may well be the very first non-Longswamp Mertz to arrive in Northumberland, Union or Snyder county. I think he first appeared there in time for the 1830 Census. This mystery John was born 19 Nov 1791 and we know from his death certificate that he was born in Kutztown, Berks County and that his parents were John and Margaret. Kutztown is in Maxatawny Township. John died 5 Feb 1853 in Hartley Township, Union County. His wife was Elizabeth.

A daughter of theirs was Catherine and she married Peter Bingaman. A genealogy friend who descends from this same Bingaman family -- though not from Peter and Catherine -- is the one who first brought John to my attention.

So who was this John? To start to answer this question I think one thing is clear. His father was the John Mertz, age 26-44, reported in Maxatawny Township in 1790 with a presumed wife the same age and no children yet and then in 1800 lived in the same place now with four males age 0-9.

After much consideration, I think the John in the 1790 and 1800 Census was the John who I know existed from his 1757 birth. To believe anything else would be to believe in someone I would be inventing and giving the name John, but 1757 John is known. I don't know he survived but I also don't know what happened to him if he did. So the immigrant Johannes (J) was John I, his known son John (J1) born in 1757 John II and I believe he then had this son John III born in 1791. John III is designated J1a.

I might be able to better solve this whole mystery if I could find this John in 1820 and know it was him. His father was last seen in 1810 in Maxatawny, then where does this family go?

Consider this. In the Briar Creek Church in Columbia County, where we find mention of William (H1a) and Elizabeth, typically spelled Marz, there is this citation: Johannes Merz and Maria baptized Sarah born 24 Jan 1814. Who was this John? William did have a son named John -- but we was born in 1796 so I doubt he would have been baptizing a daughter in 1814. Could the John found in Maxatawny in the 1790-1810 Census be this mystery John (or maybe his father?) mentioned in the Briar Creek Church records? Was he William's brother? But wasn't the wife of John of Maxatawny named Margaret? And wasn't his son John married to Elizabeth? Did one or the other have two wives? When I have this many questions, it definitely means more information needs to be found. And I'm still looking.

But now consider this. In 1820 there was a John Jr. (age 26-45) and John Sr. (age 45+) in Derry Township, Columbia County. Who were they? Could they have been this John and his father now moved to Derry Township?

In fact, I think it was them and I can make the case that John Jr. was the John who then would move to Hartley Township in 1830.

- 1. John Jr. in 1820 in Derry Township has two sons 0-9 and two daughters 0-9.
- 2. John who died in Hartley Township in 1853 had one known daughter born before 1820 and two sons. [It should be noted that the Sarah mentioned above baptized at Briar Creek would be a second daughter born before 1820.]
- 3.I have checked as many death certificates as I could find for grandchildren of John who died in 1853. The key field I was interested in was the birthplace of the parent of the deceased grandchild the parent that was John's son or daughter. The question was could I document any of John's children who had been born in Derry Township? The most typical answer for the birthplace of the parent of interest was Pennsylvania. [No help.] The second most popular answer was Union County, PA but I consider that the throw-away answer.
- 4. But one grandchild, Margaret Walter daughter of Peter and Catherine (Martz) Bingaman, said Catherine was born in Montour County. That's really quite interesting since Derry Township became part of Montour County when it was carved from Columbia County in 1850. It would have been Columbia County when Catharine was born but it was Montour County during almost all of Margaret's lifetime.
- 5. And one more point I'm adding in 2019. I now know that the wife of John Sr. of Derry Township was named Margaret.

So in 1830, I also have to explain where and who I think John was because the man I think was him was indexed by Ancestry has Ino Monty. I think what was transcribed Ino was clearly Jno, an oft-used abbreviation of John. And I sure can see that what was transcribed Monty looks a lot like Martz if you know that is likely who you're looking at. The key is this: We know for sure of nine children for John, two sons and seven daughters and Ino in 1830 had two sons and seven daughters.

After that, John clearly lived in Hartley Township in 1840 and 1850.

# Death and Find-a-Grave

On 30 Nov 1869, in Union County, Pennsylvania, the children of John Mertz — and, in the case of his daughters, their spouses — were listed in a document at the end of the probate of John's estate:

Lydia Mertz release to Abraham Mertz: Know all men by these presents that we, Lydia Mertz, Peter Bingman intermarried with Catharine Mertz, Harrison Bingman intermarried with Sarah Mertz, Daniel Horner intermarried with Elizabeth Mertz, Samuel Wolf intermarried with Margaret Mertz, John Dennis intermarried with Julyan Mertz, Michael Boob intermarried with Mary Ann Mertz, daughters, heirs and legal representatives of John Mertz, late of Hartley Township...

John and Elizabeth are on find-a-grave in Laurelton.

# Known Daughters

There were seven daughters named in his estate document: Lydia who never married, Catherine, Sarah, Elizabeth, Margaret, Julyan and Mary Ann.

Catherine was the one of interest to me because of her Bingaman connection. Plus she had a son Samuel I Bingaman who married Harriet Alice Klose and she descended from Mary Magdalena Mertz of Nicholas' line. So there are any number of these kind of connections I have with my friend Richard Aurand Sherer, with whom I correspond from time to time, but so far we have not established any common ancestor -- so we are not cousins in any way, so far as we know.

There were several marriages in Union and Snyder Counties of an Aurand to a Mertz (including Mary Magdalena's brother, for example) which is one way we find ourselves tracking the same families. And Richard has Yost (of York County) ancestors and Yost is a name you will find in my Mother's family tree. Then there is this line. Richard is descended from an ancestor of Peter Bingaman. He has been asking me about this Mertz line ever since I have known him. Catherine's father was John Mertz. But we have not been able to prove absolutely from which of the early Mertz lines of Berks County this John descends.

A note on Sarah. The Sarah, daughter of John, named in the release was born in about 1824. She was far too young to be the Sarah mentioned earlier, the daughter of Johannes and Maria, baptized at Briar Creek Church in Columbia County in 1814.

But I do not think it can be ruled out that Johannes of that church record was in fact this John, with first wife Maria, and whose daughter Sarah died and then he named a later daughter Sarah. I don't know it for a fact but I can't rule it out.

# **Known Sons**

John had two sons, known from Census and/or the release. One was John, age 34 and said to be an "idiot" in the 1850 Census. He is obviously the Johann Martz, died 1 Feb 1852, aged 35 years, 6 mos, 12 days, son of J. & C., buried in Laurelton, the same cemetery as John Sr. and Elizabeth. It seems apparent that John the younger didn't reproduce.

The other son was Abraham - J1a1 - and I have tried to track him.

# Birth, Parent-Proof, Designation

We know that John had a son Abraham since it was Abraham who settled John's estate and his siblings gave him their release in 1869. Since he was not living with his parents in 1850, he must have been already out on his own. The question is where was he living in the 1850-1870 time period? From Census, using a guess as to his approximate age and assuming some proximity to Union County, there are two candidates: one in Milton and one in Centre County.

I think Abraham of Centre County is the right guy. His wife was Mary Boob. There are death certificates for several children of Abraham Martz and Mary Boob and most say he and Mary born in PA which is not helpful but two say they both were born in Union County. In Abraham's case, that may or may not be true but I think it for sure places him there earlier in his life. Also Abraham's sister, Mary Ann, married Michael Boob. I think Abraham and his sister Mary Ann married Mary Boob and her brother Michael, respectively.

Abraham is designated J1a1.

One was always named Nancy in Census but he tombstone, which she shares with her brother Samuel, identifies her as Nannie. She never married apparently.

The other was Mary Ellen who shares a tombstone with her parents, she also apparently never married.

From Census, there was also a daughter Margaret and from her death certificate we learn she was the wife of Edward Moore.

# Known Sons

Six sons are linked to Abraham on find-a-grave: John, George, Samuel E, William H, Isaac and Daniel C. Five of the six are buried in Centre County, Isaac, buried in Adams County, the exception. From Census, there was one additional son, Jacob.

I have only concerned myself, generally, with tracking sons who: a.) were born before 1850 and b.) were listed as head of household in at least one Census. Using that criteria, the only sons designated are:

Samuel E and William H were also born before the 1850 Census but always lived with their father through 1880. The remaining sons were younger.

Abraham is clearly the Abraham Mertz who lived in Maidencreek Township, Berks County in 1840-1880. The question is where was he in the years prior to that? And how to not confuse him with other Abrahams? A good candidate is the Abraham Martz that lived in Ruscombmanor 1800-1830 though there seem to be some extraneous (older) people living with him, one of course being probably his mother.

But the key to the puzzle is knowing that Maria's brother was Abraham Keller and I think he looked out for her and her infant son after her husband died and then, in a way, the tables later reversed and the uncle lived with the nephew.

1800. Abraham Keller was in Ruscombmanor with a young male 0-9 (Abraham Mertz?), himself 26-45 and a female 26-45 (his sister Maria?).

1810. Abraham Keller was in Ruscombmanor. He was no doubt the male 45+. There was a female present age 26-44. Maria Mertz was exactly 45 so let's say that was her. There was a younger male present, possibly Abraham Mertz but if so his age was totally misreported as 26-45 when in fact he was 19. And there was a female 10-15 present. I have no idea who that would be but I still would bet that Maria and Abraham Mertz are present in his household.

1820. I cannot find Abraham Keller. Abraham Martz was now present in Ruscombmanor with 2 males under 10, 1 16-26, 1 26-44 and 1 45+. And females 1 under 10, 1 26-44 and 1 45+. I believe Abraham and Eva, his wife, were 29 and 27 respectively so the older folks might have been Maria Mertz and Abraham Keller. The very young children might be Abraham's children, leaving the extra male 16-26 unexplained.

1830. Abm Mertz lived in Ruscombmanor. There was a male 5-9, 10-14, 15-19, 20-29 and 50-59. Then 2 females under 5, 1 5-9, 1 10-14, 1 20-29 and 1 40-49. Abraham and Eva should be 39 and 37 so is this really bad reporting? Abraham Keller lived adjacent, age 60-69. Maria was still alive age 65, where was she? The male 20-29 seems out of place too.

1840. Abraham Mots (Motz?) was in Maidencreek. He and his wife were 40-49, which is right. The ages of the younger people are reasonable, but again Maria seems to have gone elsewhere to live.

I have scanned <u>all</u> men with given name Abraham in Berks County in 1840, no other name looks like a corrupted version of Mertz.

1850 Census. I would not have found him in Census had I not known where to look (from his 1860 Census listing) and not known the full details of who I was looking for. He and his family were indexed by Ancestry.com as Martin. But Abraham Martin (Martz really), age 59, lived in Maidencreek Township with Eve 57, Daniel 30, Amos 27, Isaac 26, Mary 21 and Abraham 12.

# **Death and Find-a-Grave**

Abraham is buried in Fleetwood Cemetery in Berks County with his mother Maria, wife Eve and son Amos and maybe other children too. Fleetwood is just east of the point where Maidencreek Township and Ruscombmanor Township abut. I think all the evidence, despite a few little tick mark issues, is that I have found Abraham in every Census.

His tombstone as listed on find-a-grave in Fleetwood has a birth date matching his known birth date. The names of other Mertzes buried at Fleetwood fit well with what is known about the names of Abraham's mother and wife.

It is the sum of the individual pieces of evidence that make the case here, the birth at Oley, the burials at Fleetwood, the connection to Abraham Keller, the death certificate of a daughter which names his wife and the 1850 Census. Everything I posit is in a way unproven but each piece of evidence strengthens the theory.

# **Known Daughters**

From Abraham's will and a land partition after he died, we know the names of all of his (surviving) children: Daniel H, Isaac H, Amos H, Abraham H (of Boon, IA), Susanna wife of John Merkel (dec'd), Maria wife of Jacob Buskirk and heirs of John H -- Joel, John S, Franklin, Ellen Koller and Sarah Hoch.

Note the pattern I have commented on elsewhere. His wife was Eva Hoch, most of his children have middle initial H. A new naming convention had arrived by the early 1800's.

Name

I've always been aware of the fact that many people believe that Johannes had a son Peter and that he married Catherine Philips. In the <u>Annals of Berks County</u> by Morton Montgomery, it says that Peter, son of Johannes, was born in Oley and died in Orwigsburg and in 1793 married Catharina Phillips of Bern and their children were: Christina, John, Peter, Samuel, Kate, Rosina and Elizabeth. The problem is that I have learned from experience not to trust everything that was written in these old county histories, in many cases there were major errors in what was sad.

But in this case, the information about Peter is confirmed by a different county history. In <u>The History of Dauphin County, PA</u>, there is a biography of Daniel Martz and his son Jacob Rogers Martz of that place. It reads like many other county history books. It simply names Daniel's ancestors, who it says were of Berks County, without citing any but the most basic facts and/or source references. I read it and at first totally dismissed it as possible myth.

But the more I studied it, I have come to ascribe some credibility to it. It says Daniel was the son of John who was the son of Peter who was the son of Johannes. It lists the same children for Peter as Morton Montgomery did but adds a little bit of additional biography to several that actually checks out.

And about John, it says: "John Mertz, son of Peter and Catherine (Phillips) Mertz, was born in 1801, in Berks County, and followed the calling of a miller. He was a man of education and refinement, as shown in the papers in the possession of his grandson, Jacob Rogers Martz. His position in the community was one of some prominence....He was a devoted member of the Lutheran Church. He married Sarah Powell, and their family consisted of the following children: Catherine, Daniel, Priscilla, John, William, and Charles. The death of John Mertz, the father, occurred in 1880."

I was especially intrigued by the reference to the papers in the possession of his grandson and I have tried to see if somehow they could be found in some Internet archive (with no luck) but it's possible those papers include some "family bible" kind of records perhaps tracing the family back to Johannes, the immigrant.

In addition, Charles A Fisher who wrote a book titled <u>Early Pennsylvania Births 1675-1785</u> lists Peter born 9 Mar 1769 as a son of Johannes and Rosina as if he had found an actual birth record. Now I know this Fisher source quite well. He most definitely used church records, which typically give a birth date and the name of the parents, as one basis for his statements.

But Fisher also used tombstones as another basis. If Fisher found a tombstone of a person and it gave either his birth date or his age at death (from which a birth date could be computed), Fisher used that as a basis to include them in his book. Yeah, I agree, a tombstone is proof that such a person existed and when he was born — but how does Fisher then infer who the guy's parents were?

So I have always had a little skepticism about whether to believe that Johannes had a son Peter and whether I could trust these sources as to the names of his children. I have learned over the years to not trust something just because someone, I don't care who, says it is so. I wanted at least some evidence.

But then as part of my Mærtz Hierarchical Project, an attempt to identify every male of this name born in America before 1850 and link them back to their immigrant ancestor, I became aware of some things I had never known before:

- 1. There was a Peter Mertz buried in Orwigsburg and whose tombstone indicates an 1833 date of death. He's listed on find-a-grave.
- 2. His wife was named Catherine. She is not on find-a-grave, but an Orwigsburg church record of her death says she was the wife of Peter.
- 3. Christina Mertz Zimmerman (1799-1884) is also buried in Orwigsburg and a pastoral note recording her death says she was the daughter of Peter & Catherine Philip Mertz.
- 4. And then it dawned on me that the 1793 marriage I had long been aware of said to be of Peter Mertz and Catherine Filbs was actually Peter Mertz and Catherine Phillips (her name corrupted to Filbs) and moreover that marriage was documented by the same pastor who had married Melchior Mertz (Peter's presumed brother) to Anna Maria Keller.

This all gave real credibility to the statements made by Morton Montgomery about Peter and I take the connection with Melchior to be compelling. Peter is designated J3.

[As an aside, on the Internet, I found a book detailing the story of Susanna Cox who was hung in Berks County sometime in the late 1790's (as I recall) for the crime, I think, of killing her baby — which baby was apparently the result of Susanna being raped. The book alleges that there is some evidence that the rapist was Peter Mertz and they surmise he was this Peter, son of Johannes.]

Peter is hard to find in Census. He may be the Peter Mertz listed in Cumru Township, Berks County in 1810 and then Pine Grove Township, Schuylkill County in 1820. He should also be in Schuylkill County in 1830 since he died there in 1833, but I can't find him.

# Discrepancies

His memorial on find-a-grave cites his tombstone as to his age at death and it says 17y, 5m, 7d with a comment there too that says "hard to read." Clearly the 17y part is wrong so arguably maybe it was, for example, 67y. But if Charles Fisher is right about Peter's date of birth, the tombstone should say 64y, 3m, 5d. and in fact I had always assumed Fisher got Peter's birth date from his tombstone so in any event that is how he must have read it. I have no explanation of how these two apparent readings of the same age on a tombstone are so wildly different.

# Known Daughters

According to the county histories, his daughters were Christina, Kate, Rosina and Elizabeth. On one list I have seen Christina was called Christian but I'm pretty confident she was Christina, clearly the Christina Zimmerman (1799-1884) about which the pastoral note said daughter of Peter & Catherine Philip Mertz. Christina is buried in Orwigsburg in the same cemetery where her brother Samuel is buried and she is linked to her parents on find-a-grave.

The Dauphin county history adds that Kate married Jacob Bock, Rosina married Jacob Deibert and Elizabeth married Jacob Runkel (so Peter had three sons-in-law named Jacob).

Elizabeth, too, is on find-a-grave and linked to her parents.

According to the county histories, his sons were John, Peter and Samuel. Both histories list his children in the same order: Christina, John, Peter, Samuel, Kate, Rosina, Elizabeth. I am assuming that is their birth order.

Complicating the search for Peter's sons is that Schuylkill County seems to be a place that does not confirm to a pattern that is fairly dependable in other places — that all of the Mertzes or Martzes of the place had a common original American ancestor. Not so Schuylkill County and even not so south central Schuylkill County (Cressona, Schuylkill Haven, Orwigsburg, and Brunswick and Manheim — North and South — Townships).

Maybe this is because Schuylkill County adjoins eight other counties — Lebanon, Dauphin, Northumberland, Columbia, Luzerne, Carbon, Lehigh and Berks — and Mærtzes were early residents in most of those. And the south central part of the county specifically adjoins Berks County where I have enumerated five different original American ancestors.

In any event, there was a least one other unrelated Mertz line in Schuylkill County in addition to Peter's. The other was that of Henry who I have designated N3a. His sons, known from his wife's father's estate file included: John, Jacob, Henry, Philip, Samuel and Joseph. Obviously, there is a little overlap in those names with the names of Peter's sons.

And to further complicate matters, there was a Samuel Martz and a David Martz, both born in the mid-1790's, who both showed up first in Manheim Township (where Henry lived). My best guess is they were Henry's brothers. Both of them had sons named John and Samuel (and other more unique names like Joshua, Reuben, Solomon).

Nonetheless, I believe I have been able to track Peter's sons and not confuse John and Samuel with all the others of those two names.

J3a John born 1801. He may be the easiest to identify since we learn so much about him from the Dauphin county history, that he married Sarah Powell and that he, for the most part, never lived in Schuylkill County. I'm fairly certain therefore I have found John, first in Bern or Tulpehocken Township, Berks County, later Marion Township (Stouchsburg area). His family then ends up in either Stouchsburg or the nearby Myerstown area of Lebanon County. Remember, Catherine Philips was said to have been of Bern in the county history.

So we know John was born in about 1801, I assume Peter's sons were named in birth order and I observe that, assuming I have correctly identified Peter in 1820, he had two sons age 0-9 in that decade — these three "facts" taken together indicates that Peter and Samuel were born later than 1801 maybe even after 1810.

J3b Peter born 1812. I first became aware of Peter when a woman named Sue Angelo wrote me about her husband's ancestor Daniel Mertz who she referred to as David (those two names often get read as the other in old handwritten manuscripts):

"There were two people around the same age in Schuylkill County in the late 1800s per Censuses named David Mertz. I believe, by process of elimination and burial location that the David in my husband's line (his GGG Grandfather), is the David listed on the 1850 and 1860 Census as the eldest son of Peter and Eliza Mertz. I have located Peter and Eliza's graves in Schuylkill Haven Union Cemetery, Peter was born in 1812. They are located in North Mannheim Township in 1850. I am unable to go back any further in this line and was wondering if you could be of any help. I did read your writings on your website and I am guessing that Peter could be a son/grandson of your possible N3a Henry (son of Conrad, grandson of Nicholas) based off the location. I would love to find some concrete proof of this."

At the time Sue visited my website, I had not learned the names of Henry's children which we now know did not include a Peter and I had not focused on the list of supposed children of Peter's which does. I think the better candidate to be Peter's father is Peter.

J3c Samuel born 1817. There were several Samuels listed in various pre-1850 Censuses in Schuylkill County and the aforementioned Henry had a son Samuel too complicating matters. Further, there is a Samuel born in the mid-1790's who lived in Barry Township in 1850, so who was who? But one Samuel stayed close to Orwigsburg and is buried there. I have gone with him as Peter's son.

I think the woman indexed as Catherine Meet in 1850 is her, age 78, living with Diana Zimmerman age 40 and other Zimmermans. Whether Diana was really Christina, Catherine's daughter, with her age mis-reported or whether there is some other explanation, I don't know.

Then as I was fleshing out what I knew about Daniel of Dauphin County (who I thought was the son of Jacob of the same place based on J L Floyd's statement that Jacob had a son Daniel — I now think he did but it was a different Daniel) and found John age 66 living with Daniel in 1870, I realized that must be his father and I remembered this was what the county history said.

It all fit and I now basically buy into the whole family history as stated in that book. The idea that Peter had a son John is stated in several places, it's just I never knew which adult John — or even whether he survived to adulthood — it was. Now, knowing who I was looking for and that he did live to at least 1870, and knowing a little bit about his family as told in the county history book, I think I have found glimpses of John over the years.

John is designated J3a.

This is what the county history book says about John: "John Mertz, son of Peter and Catherine (Phillips) Mertz, was born in 1801, in Berks County, and followed the calling of a miller. He was a man of education and refinement, as shown in the papers in the possession of his grandson, Jacob Rogers Martz. His position in the community was one of some prominence....He was a devoted member of the Lutheran Church. He married Sarah Powell, and their family consisted of the following children: Catherine, Daniel, Priscilla, John, William, and Charles. The death of John Mertz, the father, occurred in 1880.

The statement about the "*papers in the hands of Jacob Rogers Martz*" is especially intriguing. It makes me wonder if some of the whole family history back to Johannes the immigrant was given there. I wish it explained further. I'd love to see those papers.

For someone who achieved some level of prominence (according to the county history), it is hard in Census to be certain I have the right John (there were too many).

I have a few clues. A daughter is buried in Stouchsburg which is in Marion Township and a son is said to have been born in Bern Township, both Berks County places. Marion was formed from Tulpehocken and Heidelberg Townships in 1844. Two sons (and a daughter I think) later lived in Myerstown and/or Jackson Township, Lebanon County — which borders Marion Township.

There are several candidates in the 1840 Census in Bern and/or Tulpehocken Township, but none look exactly right. I seriously considered maybe he was the John in 1840 in Norwe-gian Township, Schuylkill County but that doesn't seem right either.

I did though find him in 1850 in Tulpehocken Township and then in 1860, I'm sure he is John in Marion Township. The ages of everyone and the presence of Sarah, William and Charles in the household and a younger John nearby adds credibility to my assertion that this is him. It would have been nice had his occupation been miller.

In 1870, he lived with his son Daniel in Millersburg. In 1880, there was a John Mertz living in Myerstown, Lebanon County, the father of Kate Kunkleman. I would bet she was the daughter Catherine mentioned in the county history.

So John and his family were associated with Stouchsburg and later Myerstown, some are buried in each place and there are multiple Census listings of the family in both places.

# Known Daughters

The PA death certificate of Mrs. Priscilla Brown, born 10 Dec 1827 died 23 Sep 1908, says she was the daughter of John Martz and Sarah Paulis. No specificity for any of their birth places was given, all said just Pennsylvania. But it is interesting that Priscilla was to be buried in Stouchsburg.

# Parent-Proof

The county history biography of her son Daniel gives her name as Sarah Powell, consistent with her name in the 1850 and 1860 Census. It is also consistent with the death certificate of her daughter Priscilla born in 1827 which gives her name as Sarah Paulis (close enough to Powell, I think, to not raise any questions).

So why does the death certificate of her son William say his parents were John Mertz and Catherine Stack? Had Priscilla been born later than William, I might think Catherine had been a first wife for John, but she was born before William.

I think it is just an error. I also note that the informant was William's attending physician and I'm not really sure it says Catherine Stack, I maybe could read it more like Catherine Haak and Willam's own wife was Mary Haak, possibly a source of the informant's confusion.

The <u>History of Dauphin County</u> gives a biography of Daniel Martz and even though there were four Daniel Martz in the 1850 Census in Dauphin County, I am sure I have correctly identified the one the history book says was the son of John.

The biography says: "Daniel Martz, son of John and Sarah (Powell) Mertz, was born in Berks County, where he received a common school education, and subsequently learned the business of butcher, in which he was engaged the greater part of his life. He came to Dauphin County and lived for a short time in Upper Paxton Township, removing in 1851 to Millersburg, where he was engaged in business for himself as a butcher until the latter part of his life, when he abandoned this calling and for a few years was the proprietor of a store. At the time of his death, he was the owner of two valuable properties. He was one of the founders of the Millersburg Lutheran Church.

*Mr. Martz married, 30 Dec 1849, Sarah Seibert, and their children were: Prisiclla A married George D Albert, John married Mary Smith, Jacob Rogers and Malinda E E married Charles Stricken. The death of the father of this family occurred 22 Jan 1895, and that of the mother 20 Feb 1868. Both are buried at Millersburg, the spot being marked by a monument."* 

Daniel is designated J3a1.

# **Relocated and Census Tracking**

There are actually four men named Daniel Martz in Dauphin County in 1850, one of whom is my friend Louis Fackler's ancestor and another his son. Plus, I think Jacob Martz had a son Daniel.

Finally there is this one J3a1 and his Census history conforms to his biography as given in the county history. He first was in Upper Paxton and then always in Millersburg after that.

In the 1850 Census, there was only one son, John, age 1. He continued to live with his parents through the 1870 Census. There are 107 John Martz (or similar) in the 1880 Census born in about 1849. Even when I restrict the search to just those born in Pennsylvania, I don't immediately recognize this John. He is not designated since I am unable to track him after 1870.
Normally, I would not concern myself with any sons born later but in this case, I do designate and track son Jacob Rogers who was born in 1851 but who, with his unique name, and "papers in his possession" is a key person of this family.

The county history book gives this biography: "Jacob Rogers Martz son of Daniel and Sarah (Powell) Martz, was born 21 Sep 1851 in Upper Paxton Township, and attended the schools of Millersburg. At the age of twelve years, with the consent of his parents, he went to live with Uriah Martz (no relation) on a farm in Upper Paxton were he attended school for two years. At the end of that time, he returned home, remaining until 1871. He then was a clerk in a general store. In the latter part of 1874 he went to Columbus, OH where he was a clerk in a general store, after which he went to Chicago, where for about three years, he was similarly employed. He then went to St. Louis.

Later he returned home, and in partnership with his father established himself as a butcher. conducting the business for a number of years. In 1889, he accepted a position as clerk in the Brownstone stores in Walltonville. For over thirty years he was a member of the Millersburg Lutheran Church withdrawing to unite with the Lutheran church at Hummelstown.

*Mr. Martz married, 2 Apr 1874, Mary Hannah Beistiel born 5 Oct 1849 in Halifax. Their children were: Charles Moses, Luther Farnsler and Fleeda Ethel Estelle. The death of the mother occurred 26 Aug 1900, she was buried at Oak Hill in Millersburg."*

The monument has Jacob's name and his birth date on it — but it is not where he was buried. Jacob died in 1928 (his tombstone says 1929) and he was buried in Hummelstown.

## Death and Find-a-Grave

Peter is on find-a-grave and linked to his wife, both buried at Schuylkill Haven.

Peter's will proved 27 Oct 1891. The will was not specifically dated, but when it was probated his sons said it had been written in 1874. He named wife Eliza and named his sons Daniel F and Samuel A his Executors. However, as part of the proving of the will, Samuel A Martz and his brother W J Martz certified that Daniel F was now deceased. And in fact, W J Martz was appointed the Executor.

## Known Sons

His sons from the 1850 census were Daniel age 15, Samuel 10, James 6 and John 4 who are designated J3b1, J3b2, J3b3 and J3b4 respectively. All four sons were also present in Peter's 1860 household and then only John in 1870.

James is the easiest to find. He lived in Cressona in 1870 age 25 then Easton in 1880 age 34. He died in 1885 and his death notice in a Pottsville newspaper said he died at Easton at age 40, was formerly of Cressona, was the son of Peter Mertz of Panther Valley and was the brother of (Pottsville) Councilman William John Mertz. The reference to Panther Valley comes up again in the 1891 death notice of Eliza Mertz who died there. She was said to be the mother of Councilman Mertz and is survived by her husband, six married daughters and two sons: W J of Pottsville (i.e. the Councilman) and Samuel A of Lehighton.

From these two death notices, I think it becomes clear that son John in 1850 and 1860 was later known as William John and actually more often as William J or just W J. He lived out his life in Pottsville.

With the clue that Samuel by 1891 was of Lehighton, I can be sure that I have found him, first in Cressona in 1870 then Carbon County by 1880 and he was buried in Lehighton.

Which brings me to Daniel. Daniel signed as Daniel F when he witnessed his father's will and I strongly suspect he is the Daniel Francis Mertz (1834-1879) buried in the same cemetery as his father, it seems in the same plot. I believe too he registered for the Civil War draft as Danl F Martz age 35. So I think I have correctly identified him and know the basic facts of his life.

However there was another Daniel Martz (Mertz) buried in that same cemetery. This other Daniel lived to 1903 so couldn't have been Peter's son who clearly predeceased his father. I am not certain I know who he was but I believe I can make the case he was the son of David who died in the 1840's and his wife Christina and this other Daniel is designated N3c1.

The death certificate of Emma R (Mertz) Eiler says she was the daughter of Peter and Eliza (Moyer) Mertz. She is buried in Cressona and linked on her find-a-grave memorial to her husband Charles.

The death certificate of Anna Cosiah (Mertz) Freeze says she was the daughter of Peter and Eliza (Moyer) Mertz. She is buried in Cressona and shares a tombstone with her husband William Freese.

His wife is identified as Catherine Mardis on her husband's death certificate. Her name is given as Kate (Mardis) Mertz, wife of Wm J, and daughter of Wm Mardis and Margaret Lodgson. Her name is Kate E on her find-a-grave memorial.

## Birth, Parent-Proof, Designation

It is said in any number of places that Peter had a son Samuel. This s proven by the fact that Samuel was both a witness and Executor of his father's will. He is designated J3c.

Whether I have for sure identified the correct Samuel is open for discussion. I picked this one because he too is buried in Orwigsburg. His 1817 birth date seems a little late to me, but Peter married in 1793 so there is not room for another generation.

## **Relocated and Census Tracking**

The Samuel buried in Orwigsburg is definitely the Samuel age 33 listed in North Manheim Township in 1850 with wife Ala (Abigail I assume) and daughter Catharine age 9. Also present in the household is Jacob Deibert age 18. The Dauphin County history says Samuel's sister Rosina married Jacob Deibert - I have found them in the 1850 Census living in Orwigsburg, Jacob age 42, his wife Rosina 41 — so the 18-year old Jacob living with Samuel was no doubt their son).

This little fact, Jacob Diebert living with this particular Samuel in 1850, gives credibility to the Dauphin County history and is very strong evidence that I have correctly identified this particular Samuel as Peter's son.

# Death and Find-a-Grave

His find-a-grave memorial says he was the husband of Abigail Ketner, they had been married 17 years and he was the father of two daughters.

## **Known Daughters**

Both of those daughters are buried in Orwigsburg: Mary Elisabeth (1848-1849) who's tombstone says daughter of Samuel and Abigail Mertz and Catherine (Mertz) Deibert (1841-1881) whose tombstone also says she was the daughter of Samuel and Abigail Mertz. We know Catherine too from her presence in her mother's household in 1860.

In 2020, I realized that there appeared to be two find-a-grave memorials for Samuel's daughter Catherine who married Daniel D Deibert — though the dates of birth and death were different on the two memorials. It took me awhile to sort it out. I believe Daniel married first Catharine Mertz and she died in 1881 and then in 1887, Daniel married Catherine Kepner.

The correct memorial for Catherine (Mertz) Deibert has her buried at Zions Red Church where her father is buried. But there is no sign of her husband, Daniel D Deibert in that cemetery. Instead he is at St John's in Auburn with second wife Catherine (Kepner) Deibert. So I believe there is only one Daniel D Deibert and I will try to get this sorted out on find-a-grave.
