SEBASTIAN MARTZ AND HIS DESCENDANTS

This is one of eight "original ancestor" books that comprise the Mærtz Hierarchical Project. Mærtz is used to encompass persons named Mertz and Martz (and occasional other spelling variations).

Hierarchical Project describes a designation system wherein immigrants of this name are given one letter designations — Sebastian is S — and each male descendant of up to possibly six generations is given a 2, 3, 4, 5 or 6 character designation code which indicates the exact way in which that descendant relates back to the original ancestor.

For example: S2a4b1 would be the first son (1) of the second son (b) of the fourth son (4) of the first son (a) of the second son (2) of Sebastian (S).

A project like this needs to have some limits and the general limits in this project are it covers males born before 1850 who then appeared by 1880 as head of household in their own right in Census.

The persons so designated are covered in this book sequentially — that is to say all persons whose designation is or starts with S1 follow S and come before S2. All persons whose designation is or starts with S2 come before S3. And so forth.

Birth, Parent-Proof, Designation

A man named Sebastian Martz died in Rockingham County, Virginia leaving a will he wrote in 1815 and that was recorded in the Spring of 1818. He was a large landowner and was the father of seven sons and two daughters. He was listed in Rockingham in the 1810 Census and likely was listed there in 1790 and 1800, but those Census records for Virginia have been lost. It is believed he was the man named as Bastian Mersh whose 5 Mar 1762 marriage to Magd(alena) Burghard was recorded in the records of the German Reformed Church in Frederick, Maryland.

I was able to learn a lot about Sebastian and his descendants by visiting the Rockingham County Historical Society. Sebastian's family was a prominent and large family of early Rockingham and their presence there can easily be documented by their wills, tombstones, tax records and several books on the families they intermarried with.

I assign Sebastian the designation code S.

A book I found at the Rockingham Historical Society, <u>Shadowed by the Massanutten</u>, by William Algernon Good, gives an interesting biography of Sebastian.

"Sebastian Martz married Mary Magdalene Burkhart, daughter of John, 5 Mar 1762 at the Reformed Church of Frederick, MD. Sebastian came to Augusta County (the part now Rockingham) sometime before 19 Mar 1777 when he purchased 545 acres near where the village of Tenth Legion now stands. He named his farm 'The Toll House Farm'.

Tradition says he did favors for Thomas Jefferson by keeping his colleagues in line with Jefferson's ideas, and for so doing Jefferson named the Legion here the Tenth, thus the name Tenth Legion. A school, the first in this area, was built near his home."

Similar things are stated by Ralph Fraley Martz in his book <u>The Martzes of Maryland</u> who adds these snippets:

"The Martzes lived in Frederick County, MD and some of them moved into the Shenandoah Valley of Virginia.

Sebastian rented his farm for some time before he actually bought it in 1777.

There was an Inn on the farm at a spring on the main stagecoach road connecting Maryland to the Carolinas.

Sebastian and his family collected the "tolls" which consisted of wood, hides, feathers and grains. He hauled these raw products to Frederick, MD where he traded these products for manufactured goods such as boots, shoes, leather, flour, sugar, salt and linen goods.

Sebastian Martz served as Thomas Jefferson's right-hand man. Jefferson liked him so much that he renamed his area as the 'Tenth Legion'.

I have no idea the credibility of all of that. Some facts seem documented, some not. It may all be true, but if Sebastian were my ancestor, I would want some evidence especially of his supposed (but interesting) relationship to Thomas Jefferson.

For example, I have an ancestor, Moses Collett, whose descendants say he moved to western Virginia and leased his land from George Washington. I found that interesting but I was skeptical. But indeed, among the published papers and letters of George Washington, there is a letter from Washington to Isaac Collett, Moses' son, about overdue rents. There it was, it really was true and provable that Moses had leased his land from Washington.

I've done a search to see if there is anything other than Martz family tradition showing a link between Jefferson and Sebastian and I came up empty. Maybe Jefferson's papers haven't been digitized and made searchable the way Washington's have, and maybe there is something someone can find among Jefferson's papers to make the case — but until such a document is found, I would be a little skeptical.

I also did a search for Tenth Legion and Thomas Jefferson and indeed, Jefferson apparently referred to the whole of the Shenandoah Valley as his "tenth legion" (like a baseball team might call the fans their tenth man).

Discrepancies

You don't have to do much research on Sebastian to encounter the idea that his father was Baltzer (or Balser or Balthazar) Marche (or Mertz). There is a well-known book, <u>The Martzes of Maryland</u> by Ralph Fraley Martz (RFM), that says just that.

In one place the book talks about a Balser Michell Mertz, age 54, who arrived on the ship Elizabeth in 1733. RFM says his wife was Anna, age 46, and they had three sons: George Henrich age 20 a shoemaker, Hans Jacob age 20 a shoemaker and John George age under 16.

Then in a chapter about instances of Martzes moving from Pennsylvania into Maryland, he cites "Balser Marchel married Ann Merkel. He lived near Hanover, PA....was an early arrival to Frederick County....children John Jacob, Catherine, George Henry, John Sebastian born 1740 and John Theobald."

In several different chapters devoted to the Martzes of Frederickstown or Frederick County, Maryland (the heart of RFM's book), RFM discusses three particular early Martz families who had some association with that place:

- 1. John Theobald Marche later Martz who died in 1786 Frederick. Theobald was a shoemaker. It sure sounds like John Theobald, son of Balser Marchel, and note his occupation of shoemaker, the same supposed occupation as the sons of Balser Michell Mertz. RFM adds: "The Martzes of Frederick County, MD would travel on the B&O Train to Luray, VA. There they were met by relatives who would drive them about 30 miles to their farm in the Valley of Virginia. The Martzes of Frederick always claimed that they were related to the Martzes living in the Valley of Virginia."
- 2. Sebastian Marche later Martz who married in Frederick in 1762 and then moved to Rockingham County, Virginia where he operated a toll station. The tolls were paid in the form of wool, hides feather and grains which he hauled to Frederick to sell. It sure sounds like John Sebastian born 1740 son of Balser Marchel.
- 3. John George Martz or Markle, born 1752 and died in 1822. RFM says that in 1781 George Martz bought a property called "Baltershum" which had been named for

Baltzer Michael Mertz who was born in 1679. Baltzer Michael Mertz sounds very much like Balser Michell Mertz who arrived in 1733 at age 54 (thus born in 1679). Balser Michell, according to RFM, arrived with a son under the age of 16 named John George. And both Balser Mertz and Balser Markel had a son named George Henrich or Henry. Clearly John George under age 16 in 1733 was not John George born in 1752, but it is typical of RFM's way of throwing names around all too loosely and not connecting very many dots, that the implication is that there is some connection.

Now part of the confusion of the RFM book is that in many places it is just long lists of random citations of supposed real documented events for various persons named Martz (often), but then also Marks, Merkel, Marchel, March, Moritz, Marchan, Markhan and many more — the implication is that RFM thinks those all might be alternate ways Martz was spelled at times. And RFM doesn't often enough say which past events he has cited elsewhere is applicable to some person he's profiling more in depth later.

So, RFM doesn't explicitly say that Sebastian Martz of Rockingham County and Theobald Martz and John George Martz of Frederick County were brothers or closely related nor does he explicitly say that Balser Marchell, who had sons named Theobald and Sebastian, was one and the same as Balser Michell Mertz, the 1733 immigrant born in 1679 who had a son John George.

But the fact that both Balser Michell Mertz and Balser Marchel had a wife named Ann or Anna and sons named (Hans or John) Jacob and George Henry and that Theobald, a known shoemaker, shared that occupation with those two sons of Balser Michell Mertz — all point to the conclusion that Sebastian, Theobald and John George were brothers or otherwise quite closely related.

And since you can find dozens (hundreds?) of people's family trees on the Internet which also make those connections, many other people seem to also believe that is what he was saying.

To which I say POPPYCOCK.

Let's start with Balser and the ships lists. RFM seems to have used the ship's passenger lists compiled by Rupp — which may be part of the problem. A different transcription/ translation of those lists was done by Ralph Beaver Strassburger and William Hinke. They point out many errors they feel Rupp made and in my opinion, the Strassburger lists should be considered authoritative.

Strassburger documents the passengers on the Elizabeth in 1733 as: from the captain's list, Jurigh Hendrick March age 20, Malster Mixt age 54, Hans Jacob Mixt age 20. Then translating the two signature lists, Strassburger lists: Georg Henrich Mertz, Balser Mets and Hans Jacob Mets. What the captain wrote as March looked more like Mertz where Georg Henrich signed his name and what the captain wrote as Mixt looked more like Mets where Balser and Jacob signed their names.

Strassburger also includes an alternate captain's list which names not just men over the age of 16 but all passengers and their ages. And those translated lists show Jerick Hendrick March shoemaker age 20 and Mickell Mikt farmer age 54 and Hance Jacob Mikt age 20 no occupation. Anna Mikt age 46 was on the women's list. No younger Mikt, Mets, March or Mertz children were listed.

So I can't even count up the number of mistakes in RFM's description of the passenger lists for the Elizabeth (some of which may be attributable to Rupp). For one thing, while Jacob and Balser/Malster Mikt were listed one after the other on all the lists, meaning they were together, George Henrich Mertz was in a different place on the lists — always. And why would the captain have spelled the names so differently? To infer that George Henrich on this list had any connection to Balser and Jacob is a mistake.

For another thing, the only shoemaker was George Henrich. Jacob Mikt had no occupation listed and Mickel Mikt was a farmer. And lastly, there is no mention of John George, who in any event had he been listed would have had an age stated for him as opposed just being under 16. It is my opinion that the Mikt or Mets family have nothing to do whatsoever with anyone named Martz including especially nothing to do with Sebastian nor Theobald nor John George.

Having said that, all three of those men did exist and did have some connection to Frederick County, Maryland. Here's a brief sketch that I believe accurate:

- 1. John Theobald Martz. People seem to believe he was born in 1735 in Pennsylvania but since there is evidence his son George was born in 1743, obviously he was born well before 1735, and therefore would have been named on the 1733 passenger list if it pertained. In my opinion he was likely born in Europe. Theobald died in 1786 in Frederick, Maryland and left a long line of descendants. Theobald was sometimes named in the records of the Evangelical Lutheran Church in Frederick (as a baptism sponsor in both cases) and sometimes in the Evangelical Reformed Church there. Ralph Fraley Martz states as a fact that he was Reformed. I have found record of the death of his son George in the Reformed records and RFM says that on 9 Feb 1767, George, Balser, Henry and Peter (Theobald's four sons) were all confirmed in the Reformed church. Yes, Theobald named a son Balser, but that alone does not give any credibility to RFM's assertions, in my opinion.
- 2. Sebastian Martz. People seem to believe he was born 1740 in Ratisborn, Germany. I have no idea when or where he was born nor where the idea he was born in Ratisborn, Germany comes from. I find it ridiculous though to believe that he was born in Germany in 1740 and was the son of a 1733 immigrant. But Sebastian did marry in Frederick County in 1762 and then did indeed settle in Rockingham County where he was listed in the 1810 Census and were he died in 1818. He also left a long line of descendants. His marriage was listed among the records of the Reformed church in Frederick.
- 3. John George Martz. There was a John George Mertz, later Martz, listed in the 1780's in the records of the Evangelical Lutheran Church of Frederick and I believe he was the George Mertz listed in Frederick in the 1790 Census. He died in Frederick in 1822. I have compiled strong evidence to make the case that he a.) was not related to Sebastian or Theobald and b.) was a son of the Berks County Mertz immigrant, John Henry Mertz (designated H). He definitely practiced the Lutheran faith. His descendants all came to have their name spelled Martz.

It is my opinion, none of these three men were related to any of the others.

DNA AND RELATIONSHIPS TO OTHER MERTZ/MARTZ IMMIGRANTS. There is a Mertz/Martz y-chromosone DNA project at Family Tree DNA (FTDNA). By analyzing the DNA from males named Mertz or Martz today, we can see which other Mærtz males in the project they share a common Mærtz male ancestor with and then using genealogical practices we can pretty well determine who that long ago ancestor was.

Right now we have five persons tested whose results should potentially be telling us something about Theobald or Sebastian: Were they related to each other? Did they share a common ancestor? Was either related to any other known Mærtz immigrant? Here are the five:

- A. The brother of Beth (Martz) Rasmussen, who has done exhaustive research on the Theobald Martz family. Per her research, with which I agree, she (and her brother of course) descend from Theobald. I'll call him person A and call these other five also by their letter assigned.
- B. Another person whose research, with which I agree, says he also descends from Theobald.

But here's the rub, the DNA of person A does not match the DNA of person B and if they both descend from Theobald, they should match. There are several possible explanations for the non-match:

- 1. One or the other of A or B has made an error in their research. I consider that unlikely.
- 2. Somewhere in either A's lineage back to Theobald or in B's lineage back to Theobald, there was an adoption no one is aware of. Such things happened.
- 3. Somewhere in either A's lineage back to Theobald or in B's lineage back to Theobald, there was some other kind of "non-paternal event". Such things happened.
- C. A person whose research shows, and I agree, he descends from Sebastian, in his case Sebastian's son Michael.
- D. A second person whose research shows, and I agree, he too descends from Sebastian, in his case Sebastian's son John.

The DNA of person C does match the DNA of person D, as we would expect. It is not a perfect match but within the limits of what FTDNA statisticians say indicates they likely are related.

It is also true that neither person C or person D is a match to person A or person B. And while those two do not match, I assume one or the other is carrying Theobald's DNA, though at this point I don't know which of them it is. I think this seems to rule out the idea that Theobald and Sebastian were brothers or otherwise related.

E. In a strange twist to this story, we have a person who descends apparently from another immigrant, George Mertz who immigrated in 1732 and settled in Heidelberg Township in what is today Lehigh County. (George is designated G in the Mærtz Hierarchical Project.) The DNA of Person E matches that of person B.

This George, the 1732 immigrant, had a son Philip and Philip named a son Theobald — the only other Theobald Mærtz I know of, anywhere in America. There are any number of ways that this shared DNA between the Martzes of eastern Pennsylvania and the Martzes of Frederick County can be explained. I explore that subject in more detail in both my book on Theobald Martz (T) as well as the one on George Mertz (G).

We are actively trying to find more male Mertz or Martz descendants of George, Theobald and/or Sebastian to shed more light on all of this.

Since DNA suggests that Sebastian was not related to any other immigrant Mertz or Martz family, I have to conclude he was an immigrant himself. It is possible he came to America with a father whose name is forever lost to history but until some new fact emerges, I list Sebastian as one of the eight original Mærtz immigrants.

Relocated and Census Tracking

I never really paid attention to the Martz family of Rockingham County, VA until I began the Mærtz Hierarchical Project to identify every Mærtz in every early Census and link every one back to his respective original Mærtz ancestor. It didn't take too long until I realized there were a lot of Martz households in Rockingham County starting in 1810 and continuing with a virtual explosion of people of this name by 1850. They could not be ignored.

It turns out it is not a difficult family to research. Many of the earliest of them wrote wills and there are tax records, Census, bible records, church records, tombstones and many other sources of fact to understand the first several generations of the family.

I actually greatly enjoyed finding a family that was so well researched. I have found no discordant notes to discredit any of the major findings of what I have learned from the work of others. I believe that, at least up until 1850 and probably beyond, that all of the Martzes of Rockingham descend from Sebastian. It is just one family and while within this one family, certain names were repeated, there is enough documented evidence to keep them straightened out.

The Rockingham Martz family stands in stark contrast to the Mertz families of Berks County where there were several unrelated immigrant original ancestors and where so much misinformation has been published and so much confusion exists because of the multiple use of just a few specific given names in the different families.

Ralph Fraley Martz in <u>The Martzes of Maryland</u> devotes a whole chapter to the Rockingham Martz family. Someone posted a summary family tree based on that book showing Sebastian, his children and their children — with many exact birth, death and marriage dates and places, and names of spouses — to the Genealogy.com message board in 1999 titled <u>Martz Family</u>, <u>Rockingham County</u>, <u>Virginia</u>. (Hereinafter Rockingham Martz tree.) This tree also adds some additional information, some of it erroneous, about this family. I will comment on its errors in the appropriate place.

I have verified all of the relationships among these people by my own means — based primarily on things I found in a research visit I made to the Rockingham County Historical Society in 2015. I was able to also verify many of the exact dates, though there may be some exact dates that appear herein which I took from either the Rockingham Martz tree or directly from the Ralph Fraley Martz book. If I found a specific source for a date, it is stated in context, otherwise, if it matters, some skepticism is appropriate.

So, it all begins with the 1810 Census in which we find Sebastian and several of his sons. I am quite sure the family was no doubt present in Rockingham in 1790 and 1800 too, but all Census listings for Virginia for those years was lost in a fire during the War of 1812.

Sebastian died in about 1818 so 1810 was his only appearance in Census.

Death and Find-a-Grave

The will of Sebastian Martz dated 13 Apr 1815 proved May Term 1818. He had a lot of land and gave all of his children a sizable farm.

As of summer 2015, there is no evidence of him on find-a-grave.

Known Daughters

From his will, his daughters were, presumably in order: Catherine widow of Riley Roberson and Elizabeth deceased wife of John West.

Known Sons

From his will, his sons were: John, Henry, Samuel, Jacob, Michael deceased, Martin and Peter deceased. That is the order they were listed in Sebastian's will — it is their approximate birth order, the only exception being that Peter may have been born between Samuel and Jacob. I have tracked them all:

S1 John born 1763

S2 Henry born 1765

S3 Samuel born 1768

S4 Peter born 1771

S5 Jacob born 1773

S6 Michael born 1775

Parent-Proof

I have confirmed that the marriage of Bastian Mersh and Magd Burghard was recorded 5 Mar 1762 in the records of the German Reformed Church in Frederick, MD. Sources say she was the daughter of John.

This record gives some credence to the idea that Sebastian and Theobald may have been brothers, as that is the church where Theobald also worshipped, but I think it is only coincidence.

John was named in his father's will and from the order, it would seem that John was Sebastian's oldest son.

John was listed in the 1810 Census. Though he was age 45+, I believe it is clear he was younger than Sebastian since Sebastian and his wife lived alone while John, in contrast, had what appear to be eight young children living in his household.

He is designated S1.

John married Catherine Nave 20 May 1790 in Shenandoah County, VA according to the Martz Family of Rockingham tree.

Death and Find-a-Grave

There is a memorial for Catherine on find-a-grave. It gives the dates 1769-1846. It says she was buried in the Mountain Valley Methodist Church Cemetery.

There are several problems with this memorial I am trying to get corrected. For one thing, a Solomon Martz in Clinton County, IN is linked to her as her mother — but he wasn't her son. She had a son Solomon but he lived his life in Virginia.

For another thing, her grave is listed in the cemetery transcriptions of Rockingham County at the Rockingham County Historical Society, with more specific dates Apr 1769 - 12 Aug 1846. It says she is buried at the Martz Cemetery "on a hill west of the Mountain Valley Methodist Church on what was the Martz land".

There is general agreement in the various sources that cover the Rockingham Martz family as to the names of John's sons. There is not as much agreement as to their order of birth, but I believe the <u>Masanutten</u> book is totally consistent with everything else I have learned from tombstones and Census.

I believe Sebastian was John's oldest son. He is designated S1a.

Relocated and Census Tracking

In 1820, Sebastian Martz is listed in Rockingham. A male 16-25 is present and one 45+. This Sebastian would have been 29. His grandfather would have been 45+ but he definitely had died. So it must be the younger Sebastian in Census, but then who is the older male?

Death and Find-a-Grave

As of summer 2015, there is no evidence of him on find-a-grave. However, he is listed in the cemetery database at Rockingham Historical Society. He was buried at the Martz Cemetery in the Mountain Valley area with the dates I show for him.

Known Daughters

I believe Sebastian may have had a daughter Amanda born about 1825. She would be the young female age 5-9 in 1830 and then 15-19 in 1840 living with her widowed mother and then she was reported with her brother, I believe, Noah, in 1850-1870. She probably never married.

Known Sons

Sebastian had a son Noah, born in 1820, who would have been the son age 0-9 reported with him in 1820, then one of the two sons age 10-15 reported with Catherine in 1830 and the son 20-29 reported with Catherine in 1840, the age in 1830 being off by one bracket.

The Rockingham transcription of local cemeteries says that on Noah's tombstone it says he was the brother of Marion and it also lists a Benjamin F Martz died 1891 who it says was the son of Marion and Lizzie.

But the only Marion I can find in Census was Noah's son of that name born in 1854.

There is another John, son of John J (S1d) of the same age and the only John I can find later living on his own, I believe, was John J's son of that name.

I cannot figure out who John and Sarah Martz could possibly be. A 2001 message board post by Bill Rosenthal says Noah Martz — whose birth information he only knows from Census and who he listed as a son of Sebastian and Catherine with a question mark — married Diana Dovel 21 Aug 1841, she the daughter of John and Sarah (Shuler) Dovel.

I think Bill's message board post explains the situation and so the transcription of her tombstone missed the fact that her maiden name Dovel must have been there somewhere.

There is general agreement in the various sources that cover the Rockingham Martz family as to the names of John's sons. There is not as much agreement as to their order of birth, but I believe the <u>Masanutten</u> book is totally consistent with everything else I have learned from tombstones and Census.

I believe Jacob was John's second oldest son. He is designated S1b.

Relocated and Census Tracking

He is present in Census in Rockingham starting in 1820 and then there through 1850. In those early decades, his wife is in the age bracket one younger than Jacob which calls into question her actual birth date or is it a case of her fudging her age?

I have a Family Group Sheet sent into the Rockingham Historical Society by Kathleen Fite showing two sons and a daughter born before 1820 and then one more son and three more daughters born before 1830 and then also children I know as Jacob's from the 1850 Census.

I was a little skeptical of it until I finally found Jacob Mantz in Rockingham in the 1820 Census with 2 sons and a daughter under 10.

In 1850, his children Michael 22, Emanuel 17, Nancy 15, Sarah 13 and William 10 are also present.

In 1860, Jacob had moved to Clark County, IL and only son William was present. Ancestry mistakenly attached the last name Cheshire to Jacob, Elizabeth and William.

Jacob is on find-a-grave with the dates I show for him which are in agreement with the Masanutten book.

Known Daughters

Linked to Jacob and Elizabeth on find-a-grave is daughter Mary J born 1819 who married Levi B Bryan and they are buried in Decatur County, IN. I have no reason to dispute this information.

Known Sons

According to Kathleen Fite, Jacob had six sons. I was able to track four of them. The two I couldn't track were:

Jonathan born 1815. I have no idea what happened to him. He must have died young.

Emanuel who Kathleen Fite says was born in 1833, married Celia W Smith 1 Apr 1856 in Greensburg, Indiana — where his sister Mary Jane had gone to live with husband Levi Bryan — and that he (Emanuel) died in 1864.

I cannot find Jonathan at all nor Emanuel (other than 1850 with his parents) in Census nor on find-a-grave.

Kathleen Fite's Family Group Sheet shows eleven children for Jacob and Elizabeth Martz including son Sebastian who it says was born 16 Jun 1817 and married Lydia Messerly 2 Dec 1839.

There was indeed a Sebastian Martz whose wife was Lydia and I never had any better idea of who his father might have been but until 2019 had no direct proof. Then, a correspondent sent me a "fraktur" documenting Sebastian's 17 Jun 1817 birth to parents Jacob and Elizabeth (Schmidin) Martz.

A study of the tick marks in Census shows that Jacob had two sons under 10 in 1820 — one was most certainly Sebastian.

The 1830 Census, though, is a bit of a problem. Jacob had two sons under 5 and two 5-9. The total count is not a problem, but where was Sebastian who would have been 13? Was he misreported as only 5-9 or was he off working on someone else's farm? Either is possible.

In any event, the fraktur proves that Sebastian was indeed a son of Jacob and he is designated S1b1 — this ignores Jonathan, supposedly older than Sebastian, but about whom there is no further information available.

Relocated and Census Tracking

The original Sebastian had a grandson named Sebastian, the son of John. The grandson Sebastian was born in 1791 and died in 1824. But there is clear evidence of an even younger Sebastian who I believe was a great-grandson of the original and was the son of Jacob, another son of John.

I believe this great-grandson Sebastian was the Sebastian Mantz listed in Rockingham in the 1840 Census. The problem is there was a male age 50-59 — who typically would be the one named as head of household — and a younger male age 20-29. So I believe that Sebastian in this household was the one age 20-29. I do not know who the older male was but perhaps his father-in-law.

Sebastian and Lydia were listed in Rockingham in the 1850 Census along with seven children. And by comparing the names and ages of all family members, we can be certain that the Sylvester Marte with wife Lyelin (the way Ancestry.com has transcribed their names) in the 1860 Census, then living in Illinois, was indeed Sebastian of Rockingham.

Similarly, he can be tracked to Fulton County, IL in 1870 then Holt County, MO in 1880.

Sebastian and Lydia are on find-a-grave. His obituary from the Nodaway Democrat of Maryville, MO dated 7 Sep 1899 gave some important details of his life and said he was to be buried at the Barnard Cemetery there. His birth date and marriage date are, in both cases, one or a few days off from the Kathleen Fite record but not enough to cause any concern.

Known Sons

Sebastian had four sons living with him in 1850. I can find nothing more about Solomon and John so they are not designated. For a while I thought I had found Henry but I got the wrong guy because Henry, as an adult, always went by Alexander. So Henry Alexander and Harvey are designated and tracked further. The Harvey I found was in Iowa but I'm sure it is the right Harvey for any number of reasons.

For example, clearly some of the family did move to Iowa. There is an Iowa marriage record of S G Martz who married Alice A Harmon 24 Dec 1903 in Decatur County. He was born in 1857 in Fulton County, Illinois son of Sabasten (sic) Martz. Clearly, he was the son Solon G or S G listed with his father in 1870 and 1880.

Sebastian had a son named Henry age 8 and then Henry M age 18 respectively in the 1850 and 1860 Census. When I found a Henry Marts age 39 in Macon, Missouri in 1880, who said he and both his parents had been born in Virginia and keeping in mind that by 1880, Sebastian was living in Missouri, I thought I had found Sebastian's son.

But I was wrong. A man named Roger Martz contacted me and told me he was descended from Sebastian and in tracing his ancestry, I came across a man named Alexander Marts in 1870 age 28 living in Hamilton County, IL and who said he had been born in Virginia and then he was listed as A Martz age 36 in 1880 (now in Jefferson County, IL) and he said both his parents had also been born in Virginia. I had never encountered this Alexander before and knew of no other Alexander Martz who this could be.

I have an ancestor, George William Diehl, who was always George as a boy and always William as an adult and the trick was finding the one place (in his case his tombstone) that gave his full name.

The one place Roger has found to date to explain how a boy called Henry by his parents came to call himself Alexander as an adult is the death certificate of Alexander's son Charley which said his father was Henry Elexander Martz. But even better than that, Roger also found the marriage license application of Alexander Martz to Catherine E Bumpus in 1891, both of Spring Green Township, Jefferson County and Alexander said he was age 50 and the son of Sebastian Martz and his mother's maiden name was Mesarley

Henry Alexander is designated S1b1a.

I have a photo (ca. 1908) that includes Lewis Berry and his family, along with another family that I assume to be that of Charley Martz, who was his best friend. The Berry family moved west from McGaheysville in 1905 to join Mandy and Charley Martz in Kansas or Shawnee.

We know William as the son of Jacob and Elizabeth from his presence in his parent's household in 1850 and 1860 and then in 1880, his mother Elizabeth age 83 lived with him. He is designated S1b4.

William apparently was named William St Clair Martz, a somewhat unusual name. I'm reasonably certain that was his name as there are several records on which it appears that way. The most compelling of these records is the 1913 Civil War Widow's Pension Application by his (3rd or 4th) wife Julia E. She wrote his name as William St Clair Martz but added William St. Martz as an alias. And the record of his 1895 marriage to Julia E Gray Rusk, as transcribed, gives his name as William Stmarty. This record also gives his parents names as Jacob Marty and Elizabeth Smith.

Then there is the Indiana death certificate of Frances E Gurley who says her parents were William Clair Martz and (2nd) wife Charlotte. The Indiana marriage record of William G Martz says his parents were William St Clair Martz and Lottie Bevington. And William G's Indiana death certificate says his parents were (as transcribed) William Stclaire Marty and Charlotte.

But what is most curious is that his name was sometimes written in a way that made it seem that St Martz was his surname or perhaps the St was like a title. In the 1910 Census, where the Census taker wrote last names first, a comma, then the given name — e.g. Jones, Bill — it was "St Martz, William" and the way it was transcribed by Ancestry, because each succeeding person in the family had a ditto mark for their surname, they all went in with St Martz as their surname.

William in fact has two memorials on find-a-grave and two tombstones in two different cemeteries were erected for him. On one of them, his name, his wife Fluvia's name and the names of five of their children who died as infants are all listed as if the surname was St Martz.

William and Fluvia had quite a number of children who died as infants. I believe his children who survived were:

Nora Virginia and Hattie Alameda by first wife Fluvia. Salina, Alice, William and Frances by second wife Charlotte.

Death and Find-a-Grave

There are two memorials for William on find-a-grave. It seems he has two tombstones.

At the Washington Street Cemetery in Casey, Clark County, IL, there is a marker that says Wm. St. Martz, Sergt Co F, 59th Ill Vol Inf, 1840-1913. The memorial embellishes on that marker giving his full name as William St. Clair Martz, an exact date of birth (18 Mar 1840) and exact date of death (12 Jan 1913) and the information that he was born in Virginia and died in Bellair, Crawford County, IL. He is linked on that memorial to wife Fluvia (who is buried in Bellair) and daughter Hattie Almeda Blankenbeker who is buried elsewhere in Clark County.

At that same Washington Street Cemetery there is a tombstone for Lena L Martz (1883-1942) and her tombstone has the word "Sister" on it. Her tombstone and William's are both in Section J, Row 4. Lena was William's daughter by second wife Charlotte. She was Sister to many siblings but none are buried at Washington Street Cemetery, in fact no others of the family seem to be there. (There are two other people named Martz in that cemetery, William Harrison Martz and his wife Lorene but William Harrison is of the Dauphin County, PA Martz family and is of no relation whatsoever to William St. Clair.

But in the Bellair Cemetery in Annapolis, Crawford County, IL, there is quite a large obelisk for William, his wife Fluvia and apparently quite a number of their children who all died as infants. I think the photos of this obelisk on find-a-grave are incomplete, but what photos there are show on one face "Fluvia M, wife of Wm St Martz" with the appropriate dates. This photo accompanies Fluvia's memorial. On the memorial for William St. Martz, a photo of another face of this obelisk says Wm St Martz but there are no dates carved there. And a photo shows that at the base of the obelisk the name St Martz is carved. And then linked to Fluvia and William are five children all of whom were born between 1866 and 1877 and all of whom died the year they were born (except one of them died the year after his birth). My hunch is that all those names and dates are also listed on that obelisk. The memorial for William has the same dates as the memorial in Casey — though they do not seem to appear on his tombstone.

Whoever posted all of these memorials on find-a-grave listed all in the family as surname St Martz. This includes William's second wife Charlotta for whom there is a small marker, presumably nearby, that says Lotta on top and apparently the letters L M on the face. She too was listed as Charlotta "Lotta" (Bevington) St Martz.

So where is William really buried and where did he die? In 1910, he and (3rd or 4th) wife Julia E lived in Casey. I would assume, despite what it says on his Casey memorial, that he died in Casey and not in Bellair but the distance between the two cemeteries is only 20 miles. Why would he not have been taken to Bellair where there was a large obelisk for him just waiting to have the right dates engraved? But if they did that, why would they have erected another tombstone in Casey? Lena would end up there but she didn't die until 1942. And I don't think it had anything to do with Julia E. She went to live in Terre Haute, Indiana with her daughter Bessie (Gray) Hughes after William died, died there in 1934 and was supposed to be buried there though there is no find-a-grave memorial for her.

Julia Ellen was the daughter of Samuel E and Mary Ann (Henderson) Rusk according to her death certificate and Illinois marriage record. She had been married to William Gray prior to her marriage to William Martz and had several children by him.

In fact, her daughter Bessie was reported as Bessie Martz age 12 living in William and Julia's household in 1900. I'm quite certain she was not Bessie Martz, in fact was Bessie Gray (Julia's daughter by her first marriage) and then later Bessie Hughes who Julia went to live with after William Martz died. Bessie is on find-a-grave as Bessie (Martz) Hughes daughter of William Martz and Julia Rusk but I'm certain that is in error.

The question is was Julia William's third wife or fourth wife? The only reason I raise the issue is that the family group sheet for the family of Jacob and Elizabeth (Smith) Martz (which I found on my visit to Rockingham) prepared by Kathleen Fite listed four wives for William: Fluvia Parsons, Charlotta Bevington, Mary Bennett Hughes and Julia Rusk Grey. I am sure that William's daughter Frances who was born in 1888 was Charlotte's daughter and I know that William married Julia in 1895. So it is possible that Charlotte died by 1890,

William married Mary Hughes soon thereafter and she died by 1895 when he married Julia. But there is no evidence of this scenario.

Discrepancies

The Rockingham Martz tree says he married Eliza Rex in Clinton County, IN in 1847. Indeed there is a record of that marriage, but I think it was a different Solomon Martz.

There is a Solomon with Eliza in Census in Clinton County in 1850-1880 and they are buried there in Fairhaven Cemetery.

However, Solomon of Indiana consistently says he was born in PA and in the 1850, 1860, 1870 and 1880 Census and in 1880 says both his parents were too.

Meanwhile, there is a Solomon Martz in Census in Virginia all those same years and I believe he is John's son.

The Solomon buried in Indiana is also on find-a-grave linked to John's wife Catherine back in Virginia as his mother. I believe this too is a major error and I am trying to get it corrected. There are some other Martzes in the same Indiana cemetery, all, I think, from Berks County and I suspect Solomon of Indiana is related to them.

Indeed, in the 1850 Census we find Catharine Hewling, age 45, no husband present, in Adams Township, Champaign County, OH. Living in her household is Catharine Marty, age 73 — her mother, I am quite sure.

Living in the same place were several of the younger Catherine's cousins. Benjamin Hawkins Martz and Erastus Erasmus Martz, sons of Michael were present as was Martin P Martz, son of Peter. Martin's sister and remarried mother were also there — his sister had married Benjamin Hawkins Martz, her cousin.

Discrepancies

I do not believe Henry and his wife Catharine had any sons based on an analysis of tick marks in the 1810-1830 Census and confirmed by the various sources that cover the Rockingham Martz family.

But in 1850, living in Adams Township, Champaign County, OH, in addition to two sons of Henry's brother, Michael, we also find Henry's daughter and widow both named Catharine.

And we also find a Martin Martz born 1811. I checked for him on find-a-grave and noticed he was linked to, as his mother, Catharine Martz born 1777. They are both buried in Rosedale Cemetery in Champaign County. Catherine, I'm quite sure is Henry's widow.

Martin and Catherine are also linked to, as another of Catherine's sons, a John W Martz 1799-1863, who died in the Civil War. He was buried in Vicksburg. However, John W is also listed on his parents tombstone at Rosedale Cemetery (saying he was buried in Vicksburg). The Rosedale dates for John W are 1839-1863. His father actually was Erastus Martz.

So John W is definitely erroneously linked to Catherine and I have also determined that Martin was the son of Henry's brother Peter.

I will try to get this whole mess straightened out at find-a-grave. Who knows what success I will have?

There is a problem with her find-a-grave memorial relating to two younger males erroneously linked to her as her sons. But, since the tombstone photo is there and since I know she did live late in her life with her daughter in Champaign County, I do not dispute at all that that is where she is buried.

Samuel was named in his father's will and from the order, it would seem that he was Sebastian's third oldest son.

Samuel was listed in the 1810 Census in Rockingham County, age 26-45, with eight young children.

Relocated and Census Tracking

Samuel is present in the 1810-1840 Census in Rockingham. In the 1840 Census, Samuel had a lot of older sons living with him. Then in 1850, it is Samuel's sons, Samuel and Jacob, living with their sister Maria.

Death and Find-a-Grave

Samuel is on find-a-grave and that is my source for his birth and death dates. The <u>Thomas Looker</u> book has the same date of death, 4 Nov 1847, but has his birth date as 10 Apr 1768. Someone has reversed 4/10 and 10/4, I believe it was the Looker book author.

The cemetery database at Rockingham Historical Society is in agreement as to his date of death and adds age 79 years 1 month, which I assume is the source of the idea he was born 4 Oct 1768.

Known Daughters

The Thomas Looker book lists these daughters: Marial born 1794 never married, Elizabeth married Nathaniel O'Roark, Sallie born 1798, Polly born abt 1805 married David Robinson Robertson, Lydia born 18 Nov 1811 married Curtis Yates, Rachael married Morgan Layton, Maria born 18 Jan 1813 died 12 Jan 1896 never married and Emma who it says was born 1840 (which can't possibly be right).

I think there may be some confusion between Marial and Mariah whose tombstone on finda-grave gives the dates as shown for Maria. I suspect that Marial never existed as it is clear that Mariah never married.

Maria lives with her two unmarried twin brothers, George and Jacob, in the 1850 Census. She is said to be 25. Also present in that household is Emma age 9. I think this is the Emma listed as Samuel's daughter in the Thomas Looker book. Maybe she was, but couldn't she also be a niece or great niece who for whatever reason was living with Samuel's other unmarried children?

Known Sons

His will dated 6 May 1844 proved Nov Court 1847 named only son Martin, who was appointed Executor, but it referred, without naming them, to other sons.

However, the <u>Thomas Looker</u> book documents an 1851 land partition after Samuel's death in which six sons were named: John, Abraham, Reuben, Martin, Jacob and Samuel.

The <u>Thomas Looker</u> book also lists a Michael Martz as Samuel's oldest son but has no more information on him. There was no mention of him in the land partition record.

Samuel married Mary Philips 13 Dec 1792 in Rockingham County according to the <u>Thomas Looker</u> book, which adds that she was the daughter of John Evan and Uriah (Woodley) Philips.

Find-a-Grave

She is listed on find-a-grave in the same cemetery as her husband. Only a date of birth, 1776, is given, no date of death. She is said to be buried at the Zetty Cemetery where her husband and three children are also buried.

The cemetery database at Rockingham County Historical Society also lists her at Zetty. Mary Martz, consort of Samuel, died 14 Jun 1840 (with a question mark) age 63 years 8 months (so late 1776). They add that the date of death was not legible when someone lately went out to check but had been recorded by the DAR in the 1960's.

I have gone with those dates.

But the cemetery database at Rockingham County Historical Society also lists a Mary Martz at the Martz Cemetery died 7 Mar 1855 aged 79 years [1776]. It adds there is no visible stone (it may be a case of the data first coming from an older transcription and then a later transcription effort could not find her). Mary, wife of Samuel, was possibly born in 1776, so is this his wife? It doesn't say that, just names her. However, she is listed next to Martin and I believe was his wife.

However, the $\underline{\text{Thomas Looker}}$ book picks up that 7 Mar 1855 date of death and suggests it was for Mary Philips and says also she is buried at the Martz Cemetery. The book gives her date of birth as 5 Oct 1779 (not 1776) — I'm not sure where that comes from.

In any event, I believe 1840 is the better date for her to have died. She was not named in her husband's will dated 1847 and I think had she been alive in 1850, she would have been living with her three children, Samuel, Jacob and Maria, all living together. Moreover, there was a petition filed after the death of her brother, Abraham Philips, in 1843 apparently naming Abraham's siblings as his heirs and Polly was not listed but her children were — she had certainly died by 1843. I also think she is buried at Zetty not Martz Cemetery.

An 1840 date of death is also curious, since the Looker book says Samuel and Mary had a daughter Emma in 1840. I think that is not true, but could it be that Mary died in childbirth at age 64, at Emma's birth?

Children Names

The Wiki profile of Abraham Martz includes a full transcription of a Licking County petition and series of court records "Abraham Philips adm vs Elizabeth Philips et al" spanning the 1843-1846 time period. It named about 28 persons some of whom were named Martz and their names seemed very much to line up with the names of the children of Samuel and Polly (Philips) Martz. It was posted there by Meghan Dewhurst-Conroy and I have discussed the interpretation of it with her. She believes that:

- 1. Abraham Philips was the brother of Mary "Polly" (Philips) Martz
- 2. He had recently died leaving a widow Elizabeth and no children
- 3. He owned a tract of land but had debts that could not be paid off without selling some of the land
- 4. So the court got involved to set off Elizabeth's third of that land as her dower and then to sell the remainder
- 5. Since Abraham had no children, and died intestate, all his siblings were his lawful heirs
- 6. At least two of his siblings had died. Polly was one of those two, and so the heirs of deceased siblings were named in that case.

Polly's children named in that petition were:

John, Abraham, Martin, Reuben, Jacob and Samuel Martz. These are the same six sons named on the 1851 land partition. So if there ever was a son Michael, as stated in the Thomas Looker book, he must have died before 1843 presumably without issue.

Polly Martz who the Looker book says married David Robinson Robertson. They are named in the petition as Polly Robinson and Daniel Robinson. Close enough for me.

Lydia Martz who the Looker book says married Curtis Yates listed in the petition as Lydia Yates and Curtis Yates.

Rachel Martz who the Looker book says married Morgan Layton in November 1843 was listed as Rachel Martz, which makes sense since the petition was dated September 1843.

Maria Martz. The Looker book named a Marial and a Maria. Maria supposedly married Samuel Handley according to the Looker book. But there is no mention of anyone named Handley in the petition. There could be several explanations, but I believe there was not both a Maria and a Marial, there was only Mariah, she never married and was the Maria Martz named in the petition.

The petition is also notable for who wasn't mentioned.

There was no mention in the petition of Elizabeth Martz who according to the Looker book married Nathaniel O'Roark and supposedly had children by him. There are any number of possibilities: maybe there was no daughter Elizabeth, maybe the Licking County cousins forgot about her or didn't have any idea where she was, perhaps she died early with no surviving issue.

There is no mention of Emma Martz who the Looker book listed as a daughter of Polly born in 1840 which never made no sense to me (Polly would have been 64, all her other children were born before 1815 or so).

There is one more interesting court document in Meghan's post: A day after the Sheriff was ordered to summon the full list of persons he came back to the court and said a number of persons "are not in my bailiwick". The Martzes not in his bailiwick were: Jacob Martz, Martin Martz, Lydia Yates, Maria Martz, Rachel Martz John Martz, Abraham Martz, Reuben Martz and Samuel Martz.

According to Census, John Martz was in Rockingham in 1840 and in Licking in 1850 so he must not yet have arrived in 1843. Abraham and Reuben were both in Licking in 1840 and Iowa by 1850, so they both must already have left by 1843. Polly Robinson seems to have been the only Martz actually in Licking in 1843.

Relocated and Census Tracking

Samuel Martz was not listed in the 1820 Census, though he was apparently still alive. Two John Martz were listed in Rockingham but neither was, I don't think, John (S1) as he supposedly died in 1820 and I think it was his widow Catherine who was listed.

So I have decided that John age 16-25 living with a male 45+ was perhaps, John, son of Samuel, with Samuel living with him.

In 1830, there were two John Martz, both age 30-39. I have no way of knowing which is which. One had eight persons in the household and one had ten. Arbitrarily, I give this guy 10 persons.

In 1850, John age 54, had found his way to Licking County, OH and lived with with seven younger Martzes, I assume his children.

Then in 1860, John had moved to Iowa and still lived with some of his children. I don't see him in 1870 so I'm guessing he had died.

Known Sons

Living with John in 1850 in Licking County, OH were George 32, Samuel 29, John 28, Martin 26, Elizabeth 24, Sebastian 18 and Lydia 14.

I have been able to track all of those sons except George who is not designated. The others all ended up in California.

The oldest, born 1823, was born in Virginia, the next two, born 1834 and 1838, in Ohio, the next one, born 1843, in Missouri and the youngest, born 1848, in Iowa. I think Abraham briefly of Licking County was this Abraham. The presence of his brothers in Licking County at about that time helps make the case.

Peter was named in his father's will. All sources that cover Sebastian's family show exact birth dates for all of Sebastian's sons and Peter was, according to those dates, the fourth oldest son.

Discrepancies

When Sebastian wrote his will, two of his sons, Michael and Peter, had pre-deceased him.

In the case of Michael, Sebastian simply bequeaths to Michael's children the land where Michael's widow now lives. He directs that the land ultimately is to be sold and the proceeds divided amongst Michael's children.

In the case of Peter, it is a little different in that he bequeaths the land where she now lives to his daughter-in-law Mathia but in the same way directs that the land ultimately is to be sold and the proceeds divided amongst Peter's children.

Sebastian listed his sons in the same order as their supposed birth dates would suggest — with the sole exception of Peter, who was listed last but supposedly was the fourth oldest. I do not know if he really was the youngest or whether it has something to do with the different way he mentioned Michael versus Peter.

Ralph Fraley Martz and the Rockingham Martz tree say Peter married 5 Dec 1803 and died 14 Aug 1807. As he was listed in the 1810 Census and wrote his will 11 Apr 1814, clearly his date of death is wrong. I believe the 14 Aug 1807 date is his date of marriage.

Death and Find-a-Grave

Peter wrote his will 11 Apr 1814 and it proved in the June Court 1814. His will mentioned wife Martha, four children — and "the land his father gave him". Sebastian may not have considered it yet a gift as a year later, when he wrote his will, he gave the land to Peter's widow for her use during her lifetime or widowhood.

He is listed on the Rockingham Historical Society cemetery database. They show Jacob died 11 Apr 1851 buried at the Martz Cemetery in the Tenth Legion area. The listing says age 7y 11m but I think it must be 77y 11m.

The <u>Thomas Looker</u> book says he died 7 Apr 1851 age 77 years 11 months and was buried at Martz Cemetery. So I don't know if Apr 11 or Apr 7 is correct. Nor do I know how the author of the Looker book computed his birth date as 1 May 1773, you'd think she would have gone with 7 May 1773 — but no matter really.

Finally, find-a-grave says born 30 Apr 1773 and died 7 Apr 1851.

Jacob consistently has a wife a little younger than himself in the 1810-1840 Census and then no wife in 1850 leading me to believe the 1844 date of death and age 57 years is accurate. This date also conforms to the idea that this couple had 13 children including several born after 1814.

And all of this is proven by her find-a-grave memorial which says she was born 29 Jan 1787 and died 12 Jul 1844.

Michael was named in his father's will and from the order, it would seem that he was Sebastian's fourth oldest son. However, I believe Peter was listed out of order and I believe Michael was actually the sixth oldest. Michael pre-deceased his father.

Michael was listed in the 1810 Census in Rockingham County, age 26-45 with eight young children. He is designated S6.

Relocated and Census Tracking

Michael died 30 Nov 1814 so he only was listed in the 1810 Census. After that his wife Sarah was then reported in his place in 1820 through 1850.

Death and Find-a-Grave

Michael wrote his will 15 Nov 1814 and it proved in the January Court 1815. There are references to his widow who he calls Sarah in one place and Sally in another. He did not name any of his children by Sarah but apparently he had two additional children who he called base-born (illegitimate?) and he did name them and provide for them. They were Serena and Betsy Herring. He named his brother Martin his Executor.

Michael and Sarah are buried at Martz Family Cemetery in Rockingham. This cemetery was in complete disarray until Roger Martz and his wife went there in 2020 and spent several days cleaning it up, re-establishing the fencing, and carefully re-placing, photographing and cleaning every tombstone there — and adding all of them to find-a-grave. Every descendant of anyone buried in this cemetery owes Roger a huge thank-you.

Discrepancies

The Rockingham Martz tree says Michael died 30 Nov 1841, a simple typo, it was 30 Nov 1814.

Known Daughters

Sebastian's will named four daughters of Michael's: Mary, Marthy, Clarenda and Rebecca.

Marthy married her cousin Martin P Martz and ended up in Champaign County, IL where two of her brothers also lived. Clarenda (aka Clare Ann or Claire) married first Benjamin Connor and second Thomas Conrad Conner.

Rebecca married Wellington Miller and supposedly moved to Licking County, OH, where two of her cousins also lived for a brief time. There is a Rebecca and Wellington Miller present there in the 1850 Census, he age 32, she 38, but I have no way of assuring myself it is Michael's daughter of that name.

Finally, Mary, I think, never married and stayed in Rockingham where she died. In the 1850 Census, living with Sarah were Dorilas Mertz age 47 and Mary Martz age 45. In 1860, living with Sarah were Dorilas age 58 and Mary age 56. By 1870, Sarah had died and we still find Mary 66 living with Dorilas 68. Those Censuses did not state relationships, so it might appear that Mary was the wife of Dorilas rather than his sister.

But then, consider, that Sarah's will did not name all her children but specifically named Dorilas Martz and Mary Martz. And consider that Dorilas' will left everything to his sister Mary and brother Jackson. I think Dorilas, like his sister Mary, never married.

Known Sons

Michael is really the first Rockingham Martz I ever became aware of. Several of his sons moved to Ohio and I have encountered various biographies of some of them saying they were sons of Michael who died in Rockingham County.

Michael's father Sebastian died after Michael and his will named all of Michael's children, including sons: John, Hiram, Darilus, Michael, Benjamin, Napoleon, Erastus and one more (Sarah was pregnant). The last one was Jackson.

The very curious thing is that the Rockingham Martz tree says Jackson and Erasmus were both born 26 Apr 1815, a few months after their father died and a few days after Sebastian wrote his will. But how could Sebastian know Erastus' name and not Jackson's?

The solution to that puzzle may be that Erastus' birth date on his tombstone says 9 Jul 1813 in agreement with the Thomas Looker book. That date is the same exact date given for Rebecca — so maybe Erastus was a twin but not of Jackson.

She is named as the wife of Michael in the Rockingham Martz tree. It says they married 4 Sep 1798 in Tenth Legion, VA and that she was the daughter of Benjamin and Magdalene Hawkins.

Relocated and Census Tracking

Michael was listed in the 1810 Census with a very large family and it is said he died 30 Nov 1814 and so we find Sarah in the 1820 Census as the head of a very large family.

Death and Find-a-Grave

Sarah wrote her will 22 Feb 1865. In proved Nov Term 1865. She mentioned son Dorilas, daughter Mary, son Jackson and the heirs of son Hiram. Curiously, that left a lot of her other children totally unmentioned. I think it may be that the ones she mentioned were those that stayed in or near Rockingham while the others had moved away.

All of this perhaps came to a head in this family when Hiram's son Dorilas died in 1872. His will was contested although it seems it was also resolved quickly with a settlement that seemed to cover the entirety of Michael and Sarah's family, their children if alive, and the next generation of heirs of any deceased.

I think I can explain why he is not buried with her. If we start with the 1880 Census, Napoleon was living with his son Frank in Douglas Co, IL and Hannah was living with their son Milton in Hancock County, OH.

Frank died in 1883 and is also buried, per his find-a-grave memorial, in the same cemetery as his father. What were they doing in Arkansas? The answer surely has something to do with the fact that in 1880, we find Napoleon's son Michael already there, in Perry County, AR. So apparently, sometime not long after 1880, Napoleon and Franklin both found their way to Perry County where both died.

In 1810, there is a young female age 0-4 in his household and a male 16-25 — too old to be Martin's son. In 1820, there is no young female but now a son age 10-15. And then in 1830, there is a young male 10-14 and a young female 15-19.

Then in 1840, Mary lives with a male 10-15 and one 20-29 and two young females in the same two age brackets and also an older female closer to her own age. And then in 1850, Mary lives with no Martzes.

It is very hard to make the case that any of these younger persons in any of these years were Martin's children and if any were, that they survived to the next Census — based on analysis of the tick marks.

I suspect Martin and Mary had no children who survived to adulthood. No children are listed for them in any of the various sources that cover the Rockingham Martz family.

Mary is on find-a-grave as is a photo of her tombstone which is basically unreadable today. She is, though, listed on the Rockingham Historical Society cemetery database next to Martin. They show Mary died 7 Mar 1855 age 79 years (1776) buried at the Martz Cemetery in the Tenth Legion area.
